INTRODUCTION

The Right to Information Act, 2005 has put in place a practical regime to ensure the right to information for citizens by securing access to information under the control of public authorities. An informed citizenry with access to information is vital to the functioning of democracy, to contain corruption and to hold the Governments and their instrumentalities accountable. The Act seeks to promote transparency and accountability in the working of public authorities. It provides the framework for citizens to access information which is held by or under the control of any public authority which includes the right to inspection of work, documents and records. The Act applies to all public authorities including bodies owned, controlled or substantially financed by Government as well as non-Government organistions substantially financed by Government.

Under the Right to Information Act, a Central Information Commission and State Information Commissions have been set up. The Commissions receive and inquire into complaints relating to denial of information by the public authorities and decide on second appeals against the public authorities. The Commissions are also vested with powers to impose penalty on Public Information Officers found guilty under the provisions of the Act, to recommend disciplinary action against them and to require public authorities to compensate complainants for any loss or detriment suffered. The Commissions can also direct public authorities to take appropriate steps to secure compliance with the provisions of the Act.

CHAPTER - 1

WEST BENGAL INFORMATION COMMISSION

West Bengal Information Commission was constituted by the Government of West Bengal vide Notification No. 747–PAR(AR) dated 12.12.2005 which was published in The Kolkata Gazette. The Commission was reconstituted vide Notification No 744–PAR(AR) dated 03.08.2010.

Shri Arun Kumar Bhattacharya assumed the office of State Chief Information Commissioner on 27th December, 2005 and continued upto 5th August, 2010.

Shri Sujit Kumar Sarkar joined as State Information Commissioner on $3^{\rm rd}$ December, 2009. He assumed the office of State Chief Information Commissioner, on $1^{\rm st}$ December, 2010 and continued up to $4^{\rm th}$ June, 2014.

Shri K. John Koshy assumed the office of State Information Commissioner on 1st December, 2010. He assumed additional charge of the office of the State Chief Information Commissioner on 18.06.2014.

Dr. G.D. Gautama joined as State Information Commissioner on 5th April, 2012

Suo Motu Information u/s 4(1) (b)

The Right to Information Act has envisaged that all the Public Authorities shall make a constant endeavour to take steps in accordance with the requirements of this Act to publish all relevant information for the knowledge of citizens at large and update the same at regular intervals.

The Act enjoins that all the records of the Public Authority should be duly catalogued and indexed in a manner and in the form which facilitates the right to information of citizens. For this purpose, the records are needed to be computerized within a reasonable time and connected through a network all over the country so that access to such records is facilitated.

Section 4(1)(b) has given a list of seventeen such vital information pertaining to each Public Authority which are to be published suo motu so that the public have minimum resort to the use of this Act to obtain information.

Functions: West Bengal Information Commission has been constituted under sub-section (1) and sub-section (7) of section 15 of the Right to Information (RTI) Act, 2005 vide a gazette notification No.747-PAR(AR) dated 12.12.2005 and published in the Gazette on 03.01.2006. The Commission's mandate is to exercise the powers conferred on, and to perform the functions assigned to it under the Act.

The general superintendence, direction and management of the affairs of the State Information Commission vests in the State Chief Information Commissioner who shall be assisted by the State Information Commissioner and exercise all such powers and does all such acts and things which may be exercised or done by the Information Commission autonomously without being subjected to directions by any other authority under the RTI Act.

The Act enjoins upon the State Government to provide the State Chief Information Commissioner and the State Information Commissioner with such officers and employees as may be necessary for the efficient performance of their functions under this Act, and the salaries and allowances payable to and the terms and conditions of service of the officers and other employees appointed for the purpose of this Act shall be such as may be prescribed. So far thirty (30) posts of different categories have been sanctioned by the Government. A list of posts filled is as under:-

Physical Assets - Office space is provided by the State Government.



Details of remuneration of officers and employees:

According to the provisions of section 16 (5) the RTI Act, 2005 the salaries and allowances payable to and other terms and conditions of services of -

(a) The State Chief Information Commissioner shall be the same as that of the Election Commissioner;

(b) The State Information Commissioner shall be the same as that of the Chief Secretary of the State Government:

Provided that if the State Chief Information Commissioner or an Information Commissioner, at the time of his appointment is, in receipt of a pension, other than a disability or wound pension, in respect of any previous service under the Government of India or under the Government a State, his salary in respect of the service as the Chief Information Commissioner or an Information Commissioner shall be reduced by the amount of that pension including any portion of pension which was commuted and pension equivalent of other forms of retirement benefit excluding pension equivalent of retirement gratuity:

Provided further that if the State Chief Information Commissioner or an Information Commissioner if, at the time of his appointment is, in receipt of retirement benefits in respect of any previous service rendered in a Corporation established by or under any Central Act or State Act or a Government company owned or controlled by the Central Government or the State Government, his salary in respect of the service as the Chief Information Commissioner or an Information Commissioner shall be reduced by the amount of pension equivalent to retirement benefits:

Provided also that the salaries, allowances and other conditions of service of the State Chief Information Commissioner and the Information Commissioners shall not be varied to their advantage after their appointment.

It has also been laid down under section 16(6) of the RTI Act, 2005 that the state Government shall provide the State Chief Information Commissioner and the State Information Commissioner with such officers and employees as may be necessary for the efficient performance of their functions under this Act, and the salaries and allowances payable to and the terms and conditions of service of the officers and other employees appointed for the purpose of this Act shall be such as may be prescribed.

In order to facilitate easy and quick disposal of the large number of complaints and appeals from the information-seekers, the Commission vide its Circular No. 2964-WBIC/RTI/14/08 dated 18.11.2009 has prescribed a format for submission of the complaints and appeals which has to be submitted in quadruplicate alongwith all enclosures. The circular came into effect from 01.12.2009. The relevant circular and the appeal / complaint format have been uploaded in the Commission's website.

Schedule for hearings and other important information are given in the office Notice Board. All relevant information including decisions of the Commission is published on the Commission's website.

CHAPTER - 2

ANNUAL REPORTS FOR 2013 AND 2014

Section 25(1) of the RTI Act enjoins that the State Information Commission shall, as soon as practicable after the end of each year, prepare a report on the implementation of the provisions of the Act during that year and forward a copy to the State Government.

Section 25(2) of the RTI Act, 2005 stipulates that each department shall, in relation to the Public Authorities within their jurisdiction, collect and provide such information to the State Information Commission as is required to prepare the report under this section and comply with the requirements concerning the furnishing of that information and keeping of records for the purposes of this section.

Section 25(3) stipulates that the report shall provide the following information: Each report shall state in respect of the year to which the report relates.—

- (a) the number of requests made to each public authority;
- (b) the number of decisions where applicants were not entitled to access to the documents pursuant to the requests, the provisions of this Act under which these decisions were made and the number of times such provisions were invoked;
- (c) the number of appeals referred to the Central Information Commission or State Information Commission, as the case may be, for review, the nature of the appeals and the outcome of the appeals;
- (d) particulars of any disciplinary action taken against any officer in respect of the administration of this Act;
- (e) the amount of charges collected by each public authority under this Act;
- (f) any facts which indicate and effort by the public authorities to administer and implement the spirit and intention of this Act;
- (g) recommendations for reform, including recommendations in respect of the particular public authorities, for the development, improvement, modernization, reform or amendment to this Act or other legislation or common law or any other matter relevant for operationalising the right to access information.

DISPOSAL OF RTI APPLICATIONS BY PUBLIC AUTHORITIES IN WEST BENGAL DURING THE PERIOD

West Bengal Information Commission issued instructions all the Nodal Departments and District Magistrates of the state of West Bengal, vide letter No. 438–WBIC/Admn/1R–1/15 dated 02.02.2015, to collect information in terms of Section 25(2) of RTI Act from the Public Authorities and furnish the same to the Commission by 10.03.2015.

The RTI Act under Section 26 envisages that the Governments would develop and organize awareness programmes on the rights provided under the Act. It is also expected that Public Information Officers would be trained and relevant training materials produced for their use.

Under the Central Sector Scheme on "Improving Transparency and Accountability in government through effective implementation of Right to Information Act", West Bengal Information Commission has not received any fund during 2013 for organizing seminars and workshops and producing publicity materials on RTI.

However, out of the fund received therein, Rs. 2,04,150/- was spent during 2013 and Rs. 5,850/- was spent during 2014 for organizing seminars and workshops and producing publicity materials on RTI. The details for expenditure thus incurred has been shown below in tabulated form.

IMPORTANT INITIATIVES

1. Streamlining the Commission's data management system

The Commission took up an initiative in 2012-13 to update and streamline the record keeping and monitoring system in the Commission's office. The database of receipt and disposal of cases by the Commission was incomplete due to infrastructural and other inadequacies. A comprehensive exercise was undertaken to update and verify the records to ensure that all cases received by the Commission were reflected in the database chronologically with all necessary details showing the status of processing and disposal. Though the exercise called for considerable time and painstaking effort, it was considered of vital importance to ensure systematic and orderly disposal of cases and proper monitoring. The database was updated and complete chronological list of cases with their status was prepared enabling on-going verification and effective monitoring.

2. Disposal of cases by the Commission in chronological order

Simultaneously with the exercise to streamline the data management system, the Commission took the decision in March, 2013 to dispose of cases coming before it in chronological order as far as possible except where court orders are involved, where the information relates to a matter of life and liberty and where the information relates to answer scripts which would be taken up on priority basis.

3. Comprehensive proposal for strengthening the Commission's set up

The Commission continues to be severely handicapped by shortage of manpower leading to long pendency of cases. The matter was being taken up with Government from time to time but the Commission's set up remains woefully inadequate to cope with the large number of cases coming up before it within a reasonable time. Delay in disposal of cases diminishes the utility of the RTI Act to the information seeker. After a thorough evaluation of the work load and requirements, the Commission drew up a comprehensive proposal and sent it to Government in August, 2014. No significant response has been received from Government. The matter is of utmost importance and the Commission expects that it will receive due attention and early resolution.

RECOMMENDATIONS

The Commission has made several recommendations in its Annual Reports. Many of these recommendations are still relevant but remain unimplemented. The Commission wishes to highlight the following issues while reiterating the earlier recommendations.

1. Strengthening of the Commission

The Commission sent a comprehensive proposal to Government in August, 2014 for reorganizing and strengthening the Commission's set up for its speedy and effective functioning. Attention of the Government is drawn for urgent implementation of the proposal.

2. Reporting by Government Departments for the preparation of Commission's Annual Reports

The Commission is not getting reports from many Departments regularly for preparation of Annual Reports as envisaged in the RTI act. In almost all cases where reports are received, they are incomplete and do not cover all the public authorities under the Department's jurisdiction. In fact, there is no clear information as to the number of public authorities under each Department and the number of State Public Information Officers appointed by them and their jurisdiction. In the absence of complete reports from all Departments, the Commission's Annual Reports do not give the total picture regarding implementation of the RTI Act in the state.

3. Publicizing the list of State Public Information Officers and Appellate Authorities

The Commission reiterates its earlier recommendation in this regard and requests Government to publicize the particulars of the State Public Information Officer and Appellate Authority pertaining to each office of a public authority on the office notice boards for the benefit of the public.

This matter was earlier heard by this Commission and passed an order dated 16.07.2012.

The petitioner, being aggrieved because the aspect of penalty was not considered by the Commissioner while passing the said order, filed writ petition WP 8391(W) of 2013. The Hon'ble High Court passed an order in the above writ petition on 25.03.2013 with the direction upon the Commissioner to consider in accordance with law as to whether the State Public Information Officer and/or the 1st Appellate Authority have at all been negligent in furnishing information to the petitioner, as claimed by him, or not. It was further directed that a decision to this effect shall be given within 30 days from the date of receipt of copy of this order.

The petitioner had earlier filed a writ petition WP No. 9295(W) of 2012 which was disposed off by the Hon'ble High Court on 22.06.2012 with the following direction:-

"The Commission shall consider the complaint under Section 18 of the Act lodged by the petitioner and take appropriate steps thereon in accordance with law for ensuring that not only the petitioner is informed as to whether he is entitled to the information sought for by him or not together with direction for furnishing him information if he is entitled in law, appropriate action is taken against the erring State Information Public Officer as well as the 1st Appellate Authority, if at all they have acted in a manner which has the effect of frustrating the provisions of the Act."

This order of the Hon'ble High Court was not within the knowledge of this Commission at the time of passing its order dated 16.07.2012. No record could be found in the Commission's office of having received any information in this regard from the Commission's Lawyer or any other source till receipt of the copy of the subsequent Writ Petition WP No. 8391(W) of 2013 from the Ld. Advocate of the petitioner on 19.03.2013. The petitioner also did not produce the order during the hearing of the Commission on 06.07.2012 or 05.09.2012.

In pursuance of the order of the Hon'ble High Court, dated 25.03.2013, a hearing was held by the Commission on 14.05.2013 where the complainant, SPIO and Appellate Authority were heard. The complainant filed a written statement on that day. After hearing the SPIO and the Appellate Authority, the SPIO was directed to submit a written statement by 17.05.2013 and further hearing was fixed for 21.05.2013.

The SPIO filed his written statement on 17.05.2013. The SPIO submits that the information sought by the RTI applicant related to LDP Case No. 4 of 1967 which was nearly 42 years old and the relevant records could not be readily traced out. The SPIO produced the relevant file notings to show that immediately after getting the RTI application, action was initiated on 16.11.2009 to locate the information from different sections dealing with land acquisition matters. As no records could be traced out from their own office, the LA Collector contacted the Spl. LA Judge's Court office and obtained the award copies of LDP Case No. 4 of 1967 to furnish the information finally on 03.07.2012 to the applicant. It transpired from the records of this LDP case that 102 Regent Estate was not acquired

by the LA Collector as claimed by the applicant. It also transpired that in case No. 4of 1967 JC John and Rosy Joseph were not awardees as claimed in the RTI application. The wrong particulars given by the applicant made the task of locating the correct records more difficult. The RTI application did not contain any plot numbers by which the relevant records could have been identified. The two letters from the Deputy Official Trustee of West Bengal and Administrator General of West Bengal, which the RTI applicant had submitted to the Commission with reference to the acquisition of 102 Regent Estate claimed to have been made under Case No. 4 of 1967, were never brought to the notice of the LA Collector's Office by the applicant.

After due consideration of the submissions, the Commission is satisfied that the delay in furnishing the information was essentially due to the difficulty in locating the very old records which are more than 40 years old. The fact that the premises number and names of beneficiaries given by the applicant do not tally with those of the LDP Case in question would have further made the task difficult. The Commission therefore does not consider that the SPIO has been negligent or caused deliberate delay in furnishing information.

Additional Secretary and 1st Appellate Authority submits that he has made every effort to furnish the required information to the applicant. After receiving the Commission's letter dated 08.04.2010, he requested Land Acquisition Collector, Kolkata to provide the information directly to the petitioner vide his letter no. 3390-Estt./1C-Kol-15/10 dated 04.05.2010. Again, the Appellate Authority requested the LA Collector on 25.06.2010 and 08.12.2011 to furnish the information.

The applicant did not file any 1st appeal to the public authority. On receiving the Commission's direction dated 08.04.2010 the 1st Appellate Authority directed the LA Collector to furnish the information and followed it up twice thereafter. If the 1st Appellate Authority had conducted a hearing calling the RTI applicant and the SPIO, it would have perhaps helped in speeding up the matter. However, the Commission does not consider that the 1st Appellate Authority was negligent since he issued directions to the SPIO for furnishing the information and repeatedly followed up the matter with the SPIO. Further there is no provision for penalizing the 1st Appellate Authority under the RTI Act, 2005.

In the light of the observations as above, this Commission does not find sufficient grounds for invoking penal provisions against the SPIO or the 1st Appellate Authority.

The Commission notes with serious concern that no information about the Hon'ble High Court's order dated 22.06.2012 was available with it when the RTI complaint was disposed off by the Commission vide its order dated 16.07.2012. Secretary and Registrar, West Bengal Information Commission is directed to enquire into the matter and ascertain the reasons for the lapse and fix up responsibility. The matter may also be placed before Hon'ble State Chief Information Commissioner for appropriate directions as deemed fit.

The matter is thus disposed of.

In his RTI applications dated 22.12.2009 and 02.02.2010 the applicant sought some information relating to the Regional Level Selection Test 2007 for Assistant Teachers in Madrasahs. West Bengal Madrasah Service Commission furnished information to the applicant vide Memo No. MSC/337/09 dated 06.01.2010 and Memo No.MSC/395/10 dated 24.03.2010. Dissatisfied with the information furnished, the applicant filed complaints with this Commission on 01.04.2010 and 03.05.2010.

On scrutiny of the replies furnished by the Madrasah Service Commission it is observed that the applicant in his RTI application dated 22.12.2009 wanted to know the marks scored by him as well as the marks scored by the successful candidates. In their reply dated 06.01.2010, the Madrasah Service Commission furnished information to the applicant. In his RTI application dated 02.02.2010, the applicant sought 11 point information seeking further details based on the Madrasah Service Commission's reply dated 06.01.2010. Madrasah Service Commission furnished point-wise information vide their letter dated 24.03.2010.

Dissatisfied with the reply dated 24.03.2010 from the public authority, the applicant filed his complaint dated 01.04.2010 with this Commission. He has challenged the stand of the public authority in respect of item No. 1 and 5 of his RTI application dated 02.02.2010. He has also questioned the

validity of the reply given in respect of item No. 4 of his application. He has raised the question as to how a person who scored 42 marks got preference over the applicant who had 50.50 marks. The rest of his complaint contains request for new information and hypothetical or argumentative statements. The applicant filed a further complaint with this Commission on 03.05.2010 reiterating his earlier contentions.

On careful consideration of the information furnished by the public authority vide letter dated 24.03.2010, this Commission finds that information furnished is satisfactory except in respect of item No. 1,4 and 5. In item No. 1, the applicant wanted to inspect his answer script of Paper-I. The request has been denied saying there is no provision for that. The contention of the public authority cannot be accepted. The candidate is entitled to inspect his evaluated answer script as it falls within the definition of 'Information' under the provisions of the RTI Act. In item No. 4, the applicant wanted to know what weightage was given to the candidate who scored 42 marks. The reply given by the public authority is not specific to the query. In item No.5, the applicant wanted to know the number of History Pass candidates from South Eastern Region, their names and roll numbers. The request has been denied stating that there is no provision for giving the information. The stand of the public authority is not acceptable as the information does not appear to fall within any exemption clause.

The Commission heard the matter on 18.07.2013. Secretary, West Bengal Madrasah Service Commission submitted during the hearing that all information as available with them has been furnished to the applicant. A written statement was also filed by the public authority. It transpired from these submissions that a further letter has been sent to the applicant by the public authority vide Memo No. MSC/579/10 dated 16.07.2010 giving complete break up of the marks obtained by the three candidates who were called for personality test as well as the applicant. It is stated therein that there was some mistake in the information furnished to the applicant earlier on 06.01.2010 which has been corrected now. It is observed that the total marks scored by the candidate at Sl No. 3 excluding marks for personality test was mentioned as 42 in the letter dated 06.01.2010 whereas it now stands corrected as 64.

As the main thrust of the complaint by the RTI applicant hinges on the discrepancy in the information furnished by the public authority regarding the marks obtained by the candidates, the Commission directed the Secretary WB Madrasah Service Commission to produce the records relating to all four candidates including the applicant at the next hearing on 06.08.2013.

On that date, Secretary, WB Madrasah Service Commission submitted a print-out from the Computer Data-base showing marks obtained before Personality Test by 30 History(Pass) Candidates of South Eastern Region in the panel. A letter from the Chairman, West Bengal Madrasah Service Commission was also submitted wherein it is stated that at present no document save and except the Data base contained in the hard disk regarding the 1st RLST, 2007 is available in the office of that Commission. Secretary, Madrasah Service Commission also stated that West Bengal Central School Service Commission, which conducted the examination was asked to provide the relevant documents relating to the original score sheet/tabulation sheet, mark sheets and answer script. They replied stating that the

recruitment in question was conducted by the "Committee for Selection of Teachers in Madrasahs in West Bengal" though the advertisement was published under the West Bengal Central School Service Commission and therefore, the Central School Service Commission was unable to provide the documents sought for.

From the information contained in the computer print out produced it is not possible to come to any definite conclusion regarding the discrepancy in the marks as communicated to the applicant by the Madrasah Service Commission in their different replies. It is also not clear which authority is in possession of the original records relating to the recruitment in question including the evaluated answer scripts. This Commission therefore asked SPIOs of Madrasah Service Commission, Central School Service Commission and the Department of Minority Affairs and Madrasah Education to appear before it on 27.08.2013.

SPIO, Central School Service Commission and OSD and Joint Secretary, MA&ME Department who attended the hearing were unable to throw much light about either the location of the concerned records or the respective roles of the School Service Commission and the Madrasah Service Commission in the recruitment process in question. None appeared from Madrasah Service Commission.

Minority Affairs and Madrasah Education Department being the administrative Department in respect of Madrasah education in the state, this Commission directs OSD and Joint Secretary, Department of Minority Affairs and Madrasah Education to

enquire and furnish a report to this Commission within one month as to where the records relating to the Regional Level Selection Test 2007 for Assistant Teachers in Madrasahs lie at present. The matter will be taken up by the Commission on receipt of the report.

Background

Sri Sukumar Das, Advocate, Village – Padumbasan, Ward No. 16, Post Office – Tamluk, District – Purba Medinipur submitted his R.T.I. application dated 25.11.2009 seeking 27 point information to the SPIO and Assistant Chief Engineer-II, PWD (Road), Directorate, Writers' Buildings.

SPIO forwarded the same to Exe. Engineer, Tamluk Highway Division, P. W. (Roads), Directorate Vide No. PR/RTI-(DTE)-49 / 2009/2542-R/E dated 01.12.2009 with a request to provide information within stipulated period as per provision of RTI Act.

Executive Engineer, Tamluk Highway Division requested the applicant to clarify his queries and to inspect the documents either on 22.12.2009 or on 23.12.2009 and he assured to give assistance to supply the documents as desired by him vide his letter dated 16.12.2009. But no response was received from the appellant.

SPIO Vide his letter No. PR/RTI-(DTE)-49 / 2009/2678-R/E dated 22.12.2009 informed the applicant that Query Nos. 1 to 26 were not very specific and Query No. 27 involves a lot of documents. He requested the applicant to cooperate with the concerned Executive Engineer.

Executive Engineer, Tamluk Highway Division further requested the applicant to be present either on 07.01.2010 or on 08.01.2010 to settle the matter vide his letter dated 31.12.2009, Sri Das did not respond.

Sri Das preferred 1st appeal on 22.01.2010.

Appellate Authority vide his letter dated 18.03.2010 requested the appellant to appear for an interview on 08.04.2010 where both SPIO and Executive Engineer, Tamluk Highway Division would be present.

Appellant vide his letter dated 27.04.2010 alleged that the letter of Appellate Authority was dispatched on 09.04.2010 i.e. after the date fixed to be heard and also alleged that it was clear case of ignoring accountability which caused to harassment only.

Appellate Authority replied vide his letter dated 01.06.2010 that the letter was duly dispatched on 19.03.2010 and the directorate was not responsible for any subsequent postal delay.

Being aggrieved, Sri Das submitted his 2nd appeal on 10.04.2010 before Commission requesting to order SPIO to furnish proper information as per provision of RTI Act, 2005.

Commission decided to hear both the parties on 14.07.2010.

On 14.07.2010 no one on behalf of the appellant as well as Public Authority appeared before Commission at the time of hearing despite service of notice vide No. 1629(2)-WBIC/RTI/434/10 dated 24.06.2010.

Commission after perusing the available record decided the matter on merit and passed an order being No. 1836 (3) (Order)-WBIC/RTI/434/10 dated 21.07.2010 and directed the Assistant Chief Engineer II and SPIO, PWD (Roads) Directorate to show cause within a fortnight from the date of receipt of the order as to why penalty under Section 20 of the Act shall not be imposed upon him for non-compliance of the order of the Commission to appear in the hearing on 14.07.2010 at 13.00 hrs. as fixed. The order of the Commission was received on 02.08.2010 by the Public Authority. Public Authority attended the office of Commission on 04.08.2013 and submitted his clarification dated 03.08.2013.

Appellant thereafter challenging the inaction on part of Commission to implement the order passed on 21.07.2010 particularly paragraph No. 17 of the order (indicating that appropriate steps would be taken against certain officials), moved a writ petition being W.P. No. 6606 (W) of 2012 (Sukumar Das –Vs- The State of West Bengal & Ors.)

The said writ petition was taken up for hearing and was disposed of by Hon'ble Justice Sanjib Banerjee on 26.08.2013 directing the State Information Commissioner to cause the Commission to take appropriate steps in terms of the observation at Paragraph No. 17 of the order dated July 21, 2010 passed on the petitioner's appeal. It was also further directed that necessary steps should be taken within a period of three months from the date. Accordingly date of hearing was fixed on 13.11.2013

Decision

After perusing the documents on records it appears that the reasons asserted of the non-appearance by the Public Authority was an intimation to the Commission, which they have intimated through their previous letter dt. 03.08.2010 and was not in form of show cause reply.

The Commission actually received a show cause reply with all relevant documents supporting it on 14.11.2013.

From the documents and file notings submitted by the concerned Public Authority it appears that the Commission's notice of hearing being Order No. 1629(2)-WBIC/RTI/434/10 dated 24.06.2010 was dispatched from this Commission on 29.06.2010 and Alipore Head Post Office dispatched the aforesaid notice on 12.07.2010 and subsequently delivered the hearing notice to the SPIO on 14.07.2010 (at 4.30 PM). The Public Authority received the order after the scheduled time of hearing on 14.07.2010 and for that reason it caused a delay to notify the Assistant Chief Engineer-II and SPIO, P.W. (Roads)Directorate and the Chief Engineer and Appellate Authority, P.W. (Roads)Directorate regarding the hearing listed on 14.07.2010.

The concerned Authority on receipt of the order on 02.08.2010 appeared and submitted clarification on 04.08.2010 but he did not submit any show cause reply as indicated in Paragraph 17 of the Commission's order dated 21.07.2010 nor thereafter.

The actual show cause reply came to the Commission on 14.11.2013 i.e. after three years since the receipt of the order of Commission.

The Commission is of the view that the Public Authority acted diligently and reasonably in disposing the instant RTI application of the appellant and made every effort to cooperate with the applicant seeking information except compliance with the order to show cause within stipulated period of 15 days from the date of receipt of the order as to why penalty under Section 20 of the Act shall not be imposed upon him for non-compliance with the order of the Commission to appear before the Commission at the time of hearing on 14.07.2010.

The show cause reply though submitted but not within the stipulated period of 15 days as framed

by the Commission and the act tantamount to the disobedience towards the order passed by the Commission.

At the time of hearing it was submitted by the concerned SPIO that he is on the verge of retirement. In view of the above circumstances and after considering the age of retirement of the concerned SPIO the Commission hereby imposed a symbolic penalty of Rs. 1000/-and directs Shri Arun Chowdhury, Ex. Assistant Chief Engineer-II & SPIO of P.W. (Roads) Directorate and presently posted as Superintending Engineer, Bridge Planning Circle, P.W.D. (Roads), Bhabani Bhaban, Annex Building, 1st Floor, Alipore to pay an amount of Rs. 1000/- to the Treasury through TR Form-7 in the Head of Account "0070-Other-Administrative Services-60-Other Services-800-Other Receipts-021-Collection of Fees from Information Seeker for the purpose of servicing Information – 27-Other Receipts" within 15 days from the date of receipt of the order. A copy of such TR Form shall be sent to the Commission as a mark of compliance of this order.

This disposes of the 2nd appeal of Shri Sukumar Das, accordingly and finally. Let the authenticated copies of this order be forwarded to all concerned

Without getting any information the RTI applicant preferred 1st appeal before the 1st Appellate Authority, AGM (HR&A), WBSEDCL on 03.06.2013 and subsequently 2nd appeal before the Commission on 18.07.2013.

The Commission decided to hear the case on 08.05.2014 for a decision.

Decision

The Commission perused the RTI application, the 1st appeal and the 2nd appeal.

On being asked whether any information had been furnished to the RTI applicant or not, the Senior Manager (HR&A) HRD & TRG & PIO, WBSEDCL submitted a written statement before the Commission vide memo No. GM/HRD/TRG/RTI/S-328 dtd. 07.05.2014. The Commission perused the same.

On perusal the Commission observes that after receiving the RTI application dtd. 01.04.2013 the SPIO transferred the same to the AGM (HR&A), R&MP Cell, WBSEDCL u/s 6(3) of RTI Act, 2005 vide memo No. GM/HRD/TRG/RTI/S-225 dtd. 06.04.2013 with a request to furnish the information.

The Senior Manager (HR & A) HRD & TRG & PIO, WBSEDCL furnished information to the RTI applicant vide memo No. GM/HRD/TRG/RTI/S-516 dtd. 11.09.2013. The Senior Manager (HR & A) HRD & TRG & PIO, WBSEDCL again furnished the photocopy of the OMR sheet of the answer script to the RTI applicant vide memo No. GM/HRD/TRG/RTI/S-553 dtd. 01.10.2013 . At the time of hearing the RTI applicant mentioned that he did not receive the same. The photocopy of the same was handed over to the RTI applicant at the time of hearing. In respect of the Serial No. B of the reply of the concerned SPIO, the Commission observes that the Public Authority furnished the marks secured by the last rank holder in all the test including interview marks of ST candidates.

The Commission does not accept the same. Since the RTI applicant is of unreserved category, the marks obtained by the last rank holder selected for appointment for the post of Office Executive in all the test including interview marks of unreserved candidate should be furnished to him.

The Commission accepts the reply in respect of the Serial No. A & C furnished by the SPIO. At the time of hearing the RTI applicant mentioned that he sought for the marks of all 853 candidates qualified for medical test.

The Commission opines that the disclosure of the marks of the 853 candidates will not serve any larger public interest. Therefore, the Commission orders Senior Manager (HR&A) HRD & TRG &PIO, WBSEDCL to furnish the marks secured by the last rank holder in all the test including interview marks of unreserved category and selected for appointment for the post of Office Executive to the RTI applicant within a month from the date of hearing with a compliance report to the Commission.

The SPIO & Sr. Manager (HR & A), HRD & TRG, WBSEDCL & SPIO requested the AGM (HR & A), R & MP Cell WBSEDCL vide memo no GM/HRD/TRG/RTI/S-223 dt 5.4.2013 to furnish the desired information to his end on and before 19.4.2013 so that the same can be supplied to the applicant within the period as envisaged under the said Act. The SPIO & Sr. Manager (HR & A), HRD & TRG, WBSEDCL & SPIO vide his memo no GM/HRD/TRG/RTI/S-291 dated 18.5.2013 again requested AGM(HR&A), MP Cell, WBSEDCL to furnish the information. Commission perused the same. On perusal Commission observes that the Sr. Manager (HR & A), HRD & TRG, WBSEDCL & SPIO vide memo no GM/HRD/TRG/RTI/S-511 dated 9.9.2013 furnished information to the RTI applicant. 16) Shri Kalap Majumdar (hereinafter referred to as appellant) submitted one RTI application on 08.09.2011 to the SPIO, West Bengal Central School Service commission seeking review of his answer scripts along with the same booklet type of question paper of his first Regional Selection Test(NT) 2010 for the post of Group 'D' staff. The Assistant Secretary Central School Service Commission informed the appellant vide letter No.2010/2197(VIII)/CSSC/Estt/2011 dated 15.09.2011 that there is no provision or scope in the West Bengal School Service Commission(Selection of persons for appointment to the post teacher) rules 2007 for reevaluation/scrutiny of answer scripts. By referring the aforesaid letter the appellant again submitted an application on 30.09.2011 to the Assistant Secretary, West Bengal Central School Service

Commission for inspection and obtaining certified copy of his answer scripts along with same booklet type question paper. The Assistant Secretary, West Bengal Central School Service commission informed the appellant vide letter No. 375/3869/(B)/CSSC/ESTT/2012 dated 03.03.2012 to appear personally in the office of Central School Service commission on 19.03.2012 at 12 A.M. for inspection of answer scripts. The appellant submitted an application on 12th February, 2012 stating that he wanted to get relief without any fees as stipulated time limit has been over and wanted to inspect his answer scripts and Booklet type question paper in original. In response to letter dated 12.02.2012, the SPIO informed the appellant on 23.05.2012 that fees was demanded as per decision of the chairman, Central School Service Commission.

- 17) The appellant preferred first appeal on 17.05.2012 to the Secretary, West Bengal Central School Service Commission and second appeal to the commission on 18.10.2012.
- 18) The Commission decided to hear the appeal and fixed up the date of hearing on 19.08.2014 and also directed the SPIO to submit the written statement within 04.08.14.
- 19) At the time of hearing the Commission perused the record and heard the submission of parties.
- 20) The SPIO submitted that he had sent the desired information to the appellant vide memo No. 1356/WBRSSC/NR/G-388 dated 12.08.2014 to his Email and sent compliance report to the Commission vide Memo No. 1374/WBRSSC/NR/RTI/G-388 dated 14.08.14. The Appellant submitted that furnished question booklet is not his own. The answer script booklet furnished to him is also without his signature, roll number and registration. On being asked the SPIO submitted that original booklets are destroyed by the Commission. So, they provided him sample question booklet of mid day session as the appellant was a candidate of mid day session.
- 21) The appellant has submitted that RTI application on 08.09.2011. The SPIO did not provide the information and at the time of hearing they took the plea that original records are destroyed due to long period.

Decision

- 22) Considering all aspect the Commission directed the SPIO, West Bengal Regional School Service Commission to recheck the records and provide the requisite information to the appellant within six weeks from the receipt of copy of order under intimation to the Commission, if it is not destroyed earlier. In the event the records were destroyed the relevant circular/order should be quoted and communicated to the appellant with intimation to the Commission.
- 23) Thus the appeal is disposed of.

In his RTI application dated 16.02.2010 the following items of information were sought by the applicant regarding recruitment to the post of Group D(including Night Guard) for which he was interviewed on 26.02.2009 :

- a. Marks allotted to him in the said interview.
- b. The lowest marks of the empanelled candidates under the unreserved category.
- c. The applicant's position in the final panel.
- d. The merit mist of the empanelled candidates under the unreserved category and reserved category.
- e. Name, relation and designation of the employees whose son/daughter/relatives are empanelled. SPIO, Food & Supplies Department vide his letter dated 15.03.2010 informed the applicant that the desired information was ready and requested him to deposit the fee of Rs.2/-. On 07.04.2010 the SPIO vide his letter No. 2290-FS/Sectt/RTI/2R-16/10 further informed the applicant as follows:

"the undersigned is to inform him that earlier this Deptt had issued a 'Notification' vide No. 580-FS dated 29.01.2010 exempting some information on the recruitment of Group D including Night Guard from disclosure quite in line with the provisions as laid down in the Act and published the same in the 'Notice Board' as well as in the concerned website, "epostindia. org." under the caption, "Important Information" to all concerned for their general information.

So, at this juncture, the desired information which have been covered as exempted cannot be provided to him u/s 8(1) (e) (g) & (j) or RTI Act, 2005.

As regards information as desired at a) and c) in his petition, the undersigned is to inform him that total marks allotted for him in the interview was 50 and the positions of the candidates who scored marks below the 'consideration zone marks' were not ascertained.

However, information as desired will be provided to him on further demand soon after the completion of recruitment process, going-on".

The applicant filed appeal before the Secretary & Commissioner, Food on 24.05.2010.

The Appellate Authority vide its order dated 11.06.2010 upheld the decision of the SPIO . The Appellate Authority observed that the SPIO had duly disposed of the RTI application dated 06.02.2010 by providing those information which are not exempted u/s 8 of the Act and available to the Department. The Appellate Authority accordingly dismissed the appeal petition.

The applicant filed 2nd appeal before the Commission on 24.07.2010.

The Commission fixed a hearing in the matter on 10.09.2014.

The applicant is not present at the hearing today. The public authority has furnished a statement to the Commission giving a list of empanelled candidates in the recruitment in question along with the decision of the Selection Committee meeting held on 23.12.2009. Merit list of 856 qualified candidates who appeared in the interview held during the period from 22.12.2008 to 23.09.2009 for the post of Group D including Night Guard showing their scores and rank has been furnished.

After perusal of the records the Commission observes: The SPIO in his letter dated 07.04.2010 in response to Item a) and c) has informed the RTI applicant that total marks allotted to him in the interview was 50 and the positions of the candidates who scored marks below the consideration zone marks were not ascertained. This reply does not contain any information as sought in item a) and c). He has declined to provide any information on the ground that the Department vide its notification No. 580-FS dated 29.01.2010 has exempted disclosures of such information. He however, states that information as desired will be provided on further demand soon after the completion of the recruitment process, going on. On the other hand the order of the Appellate Authority dated 11.06.2010 specifically states that the panel for recruitment of Group D including Night Guard had already been published vide Department's Memo No. 761-FS dated 05.02.2010.

The Commission finds no reason why the public authority could not provide the information sought by the RTI applicant all of which are relating to the panel published by the Department. On the validity of the notification of the Department exempting some information from disclosure as cited by the SPIO to deny the information, a decision upheld by the Appellate Authority, this Commission in a previous case had occasion to make the following observation: (Order passed on 16.09.2011 in the matter of Debasis Das Vs. Food and Supplies Department communicated vide Commission's No. 2490/1(2)(Order)-WBIC/RTI/657/11 dated 13.10.2011)

"Deputy Secretary, Food & Supplies Department submitted during the hearing, copies of Notification No. 5112/FS/O/SECTT/DP/4M-21/09 dated 04.08.2009 and Notification No. 580-FS dated 29.01.2010 issued by Food & Supplies Department exempting certain information relating to

the recruitment of LDC and Group-D u/s 8(1)(e) and (g) of the RTI Act, 2005 based on which the SPIO has denied some of the information sought by the RTI applicant.

The Commission examined the Memos issued by the Food & Supplied Department carefully. The Commission is astonished how such notifications could be issued by a Government Department. The RTI Act, 2005 and Rules framed there under confers no such authority to a Government Department. The relevant authorities under the RTI Act are to be guided by the relevant provisions of the Act and the rules framed thereunder only.

The Commission directs that the attention of the State Government be drawn in the matter."

The Commission accordingly holds the decision of the SPIO as well as the Appellate Authority, Food & Supplies Department denying the information sought by the applicant as erroneous and contrary to the provisions of the RTI Act.

The Commission directs the SPIO, Food & Supplies Department to furnish information in respect of Item (a),(b),(c) and d) of the RTI application within 15 days with a copy to the Commission. The public authority is not required to furnish any information in respect of item (e) of the RTI application since no such information has been taken from the candidates during the recruitment process. This disposes of the 2nd appeal.

In the RTI application the applicant sought several information relating to the RTI applications and 1st appeals received by the Public Authority for the period 2005 - 2006, 2006-07 & 2007-08.

On 2nd January,2009 the SPIO informed the applicant that it would take a considerable time to provide the information and as soon as the process was completed the required information would be provided. The SPIO again wrote to the applicant on 06.02.2009 providing information sought in serial No. 1, 4, 5, 8 & 9 of the RTI application and stating that the remaining items would be supplied on receipt of the fees as calculated amounting to Rs. 1744/- . In response to the 1st appeal, the Joint Secretary & Appellate Authority informed the applicant on 06.03.2009 that the remaining information would be supplied after receiving the requisite fees.

The applicant wrote to the SPIO vide letter dtd. 25.03.2009 stating that since the information was not provided within 30 days, according to Section 7 (6) of the RTI Act, the SPIO is required to provide the information free of charge. In response, SPIO informed the applicant that the remaining information cannot be provided free of cost. He further informed that the delay was due to the fact that the information covered all RTI files lying in different branches of the department and hence it was not possible to provide the information within 30 days in the absence of computerized data.

The 2^{nd} appeal has been filed seeking complete information free of cost and penalty u/s 20 of RTI Act.

A hearing in the matter was fixed by the Commission on 19.09.2014. The RTI applicant was absent.

The SPIO attended the hearing and submitted a statement from the 1st Appellate Authority wherein it was stated that the information requested was voluminous and the files were not readily available. The information was also not readily available in the formats given by the applicant and had to be "collated and created". A substantial part of the information had already been provided and the remaining information could not be furnished as the applicant refused to pay the fees.

It was further argued that information at serial No. 1, 4, 5, 8 & 9 can only be called by State Information Commission. The information at serial No. 2,3, 6 & 7 are personal information and exempt from disclosure u/s 8(1) (j) of the Act. The provision of Section 7(6) of the Act is not applicable where information requested is voluminous and has to be culled and created from large number of files; nor is it applicable to cases where it disproportionately diverts the scarce resources of the State. The appeal is vexatious and has been filed to harass the State.

The Commission adjourned the hearing to 27.11.2014 and asked the SPIO to produce all information maintained by the Public Authority in terms of Section 25(2) of the RTI Act for the relevant periods.

The SPIO and 1st Appellate Authority are present at the hearing today, 27.11.2014.

SPIO failed to produce any information to the public authority has maintained u/s 25(2) of the RTI Act. It was stated that as the matter is old and the Department was shifted to a new location, the information was not available. The 1st Appellate Authority placed before the Commission another statement vide No. 4775 dt. 18.09.2014 in continuation of the earlier statement wherein the following contentions have been made:

- (1) The appellant cannot claim relief u/s 19(3) and 18(1) of the RTI Act in the same petition and simultaneously.
- (2) The application attracts third party information which cannot be divulged without obtaining the views of the said third parties. The information is held in a fiduciary capacity which cannot be revealed u/s 8(1) (e) of the Act.
- (3) The Supreme Court has held in CA No. 6454 of 2011 that only information that available and existing can be accessed under the RTI Act. Creation of information is beyond the scope of RTI Act.

It is contended that the RTI application is therefore barred u/s 2 (f), 8 (1) (j), 8 (1) (e), 11

& 25 of the RTI Act.

It appears that the Public Authority has completely reversed its stand on providing access to the information sought. While it was initially claimed that the delay was due to the voluminous nature of the information and that the remaining part of the information would be provided after payment of the requisite fees as intimated, the Public Authority now takes the stand that the applicant is not entitled to any information including the information already furnished by the Public Authority.

Nothing in the RTI Act prevents an applicant from seeking imposition of penalty while making a second appeal u/s 19(3) of the Act. Under Section 20 of the Act the Commission is empowered to impose penalty in appropriate cases at the time of deciding any complaint or appeal. The contention of the public authority that the applicant cannot claim relief u/s 18(1) and 19(3) simultaneously is rejected.

In item No. 1 of the RTI application the number and break-up of RTI applications received by the Public Authority have been sought. Some information was furnished by the Public Authority. In item No. 4 break-up of time taken by the SPIO to dispose of the RTI applications has been sought. Again the Public Authority gave some information on this item. In item No. 5 the number of applications rejected under various Sections of the RTI Act have been sought. No information on this was provided by the Public Authority. In item No. 8 break up of the number of 1st appeals accepted / rejected and time taken for disposal have been sought and part information was provided. In Item No. 9 the applicant wants to know in how many first appeals the appellant was given an opportunity of being heard. Information was provided by the SPIO. Information sought under item No. 1, 4, 5, 8 and 9 cannot in anyway be considered as exempted information u/s 8(1)(e) and 8(1)(j) of the RTI Act. These are data relating to the public functions performed by the SPIO and the 1st Appellate Authority under the provisions of the RTI Act. These are not held by the public authority in a fiduciary relationship nor are these personal information having no relationship to public activity or interest or which would cause unwarranted invasion of the privacy of any individual. These are also not non-existent information which is to be "created".

The Hon'ble Supreme Court in CA No. 6454 of 2011 has held as follows: "The RTI Act provides access to all information that is available and existing... If a public authority has any information in the form of data or analysed data, or abstracts or statistics, an applicant may access such information, subject to the exemptions in Section 8 of the RTI Act. But where the information sought is not a part of the record of a public authority, and where such information is not required to be maintained under any law or the rules or regulations of the public authority, the RTI Act does not cast an obligation upon the public authority, to collect or collate such non-available information and then furnish it to an applicant".

While the break up of the figures sought by the applicant may not be maintained by the public authority in that format, the information is very much a part of the record of the public authority, which should be available and existing, being an integral part of the statutory functions exercised under the provisions of the RTI Act. It relates to the information required to be maintained by the public

authority and provided to the State Information Commission for preparation of Annual Reports u/s 25 of the RTI Act. The information which the public authority is required to maintain and provide to the Commission cannot be denied to an RTI applicant.

It is accordingly held that the information sought in Item Nos, 1,4,5,8 and 9 as available with the public authority cannot be denied.

In Item No. 2, applicant sought copies of the relevant pages of the application register or any other record of the applications received with dates and names and addresses of the applicant. The information does not attract any exemption clause u/s 8 except address and personal information relating to the applicants. Copies of all RTI applications and 1st appeals have been sought in Item Nos. 3 and 6 by the applicant. Copies of all orders of the first appellate authority have been sought in Item No. 7. The information sought under Item Nos. 3, 6 and 7 involves third party information. In such cases the procedure as laid down u/s 11 of the RTI Act is to be followed. However, it is appreciated that the information sought in Item Nos. 3, 6 and 7 is voluminous and it will be difficult for the public authority to provide copies of each and every RTI application, 1st appeals and orders of the 1st Appellate Authority without disproportionately diverting its time and resources.

In the light of the above discussion, the Commission holds that the public authority is not required to furnish information sought in item 3,6 and 7 by the applicant. However the Commission finds no reason why the public authority should not furnish to the applicant all information available with it in respect of Item Nos. 1,2,4,5,8 and 9 except personal information in Item No. 2.

The SPIO has already provided some information on item 1,4,5,8 and 9. However there are apparent discrepancies in the figures. In Item No. 1, a total of 165 RTI applications received are shown as forwarded to another public authority, but in Item No. 4 it is shown that full information has been provided for all 165. In Item No. 1 and 4 no RTI application is shown as rejected, but in Item No. 5, 9 applications are shown as rejected. The correctness of the figures should be verified. The Commission accordingly, directs the SPIO, L&LR Department to furnish complete information available with them in respect of Item Nos. 1,2,4,5,8 and 9 of the RTI application to the applicant

available with them in respect of Item Nos. 1,2,4,5,8 and 9 of the RTI application to the applicant after due verification and correction as may be necessary, within one month from the date of receipt of this order. If any part of the information is not maintained or is not available with the public authority, the fact should be clearly stated.

The SPIO shall furnish a compliance report to the Commission immediately thereafter. Let the authenticated copies of this order be forwarded to all concerned.

No. I 57-PAR (AR}~ I0th March, 2006- In exercise of the power conferred by sub-section(1) read with sub-section (2) of Section 27 of the Right to Information Act, 2005 (22 of 2005), the Governor is pleased hereby to make the following rules, namely:-

Rules

1. Short title and commencement -

- (1) These rules may be called the West Bengal Right to Information Rules, 2006.
- (2) They shall come into force on the date of their publication in the Official Gazzate.

2. Definitions:-

(1) In these rules, unless the context otherwise requires, -

- (a) "Act" means the Right to Information Act, 2005 (22 of 2005);
- (b) "Commission" means the West Bengal Information Commission;
- (c) "Registrar" means the Registrar of the Commission;
- (d) "Section" means section of the Act;
- (e) "State Government" means the Government of West Bengal.
- (2) Words and expressions used and not defined in these rules but defined in the Act, shall have the same meanings as respectively assigned to them in the Act.

3. Application fee -

An application containing a request in writing to the State Public Information Officer or the State Assistant Public Information Officer, as the case may be, made under sub-section (I) of Section 6 for obtaining information, shall be accompanied with a court-fee of rupees ten.

4. 'Fee for providing information -

Save as otherwise provided in the provision to sub-section (5) of Section '7, the State Public Information Officer or the State Assistant Public Information Officer, as the case may be, shall provide Information under sub-section (I), and sub-section (5), of Section 7 upon receipt or a request under Section 6, on payment of a fee of -

- (a) rupees two, for each page (in A-4 or A-3 size paper) created or copied; or
- (b) actual charge or cost price, for a copy in large size paper; or
- (c) actual cost price, for sample or model; or
- (d) rupees five for each fifteen minutes or fraction thereof, for inspection of records; or
- (e) rupees fifty per diskette or floppy, for information provided in the diskette or floppy; or
- (f) actual charge fixed for publication or rupees two per page of photocopy for extracts there from for information provided in printed form.

5. Contents of appeal to Commission under sub-Section (3) of Section 19 -

An appeal to the Commission under sub-section (3) of Section 19, shall contain the following information, namely:-

- (a) Name and address of the applicant;
- (b) Name and address of the State Public Information Officer or the State Assistant Public Information Officer, as the case may be, who passed the order;
- (c) Particulars of the order against which the appeal is made including its number and date;
- (d) Brief facts of the case;
- (e) Prayer or relief sought for by the appellant;
- (f) Grounds for such prayer relief; and
- (g) Verification by the appellant
- 6. Documents to accompany appeal to Commission under sub-section (3) of Section 19 Every appeal made to the Commission shall be accompanied by the following documents, namely:-

- (a) the attested true copy of the order against which the appeal is being preferred;
- (b) the copies of the documents relied upon by the appellant and referred to in the appeal; and
- (c) an index of the documents referred to in the appeal.

7. Procedure in deciding appeal to Commission under sub-section (30 of Section 19 -

- (1) In deciding the appeal to the commission, the commission shall :-
- (a) Hear, oral or written, evidence on oath or on affidavit from the concerned or interested person;
- (b) Peruse or inspect documents, public records or copies thereof.
- (c) Enquire through the authorized, officer for further details or facts;
- (d) Hear the State Public Information Officer or the State Assistant Public Information Officer or such officer who decided the first appeal mentioned in sub-section (I) of Section 19, as the case may be;
- (e) Hear the third party if required; and
- (f) Receive evidence on "affidavits from State Public information Officer or the State Assistant Public Information Officer or such officer who decided the first appeal mentioned in sub-section (I) of Section 19 or from the third party; if any
- (2) In deciding the appeal the Commission may ask the appellant to add any other information other than the information included in the contents of the second appeal under rule 5.

8. Service of notice by Commission-

The notice required to be issued under sub-section (9) of Section 19, by the Commission may be served in any of the following modes, namely:-

- (a) service by the p~ itself;
- (b) service by hand delivery through the process server;
- (c) service by the registered post with acknowledgement due
- (d) service through the head of office or the Department;

9. Signing of order -

The order of the Commission pronounced in open proceedings shall be in writing and authenticated by the Registrar of any other officer authorized by the Commission in this behalf.

10. Terms and conditions of officers and other employees of Commission -

The officers and other employees of the Commission shall be placed on deputation from the State Government on the usual terms and conditions

HIGH COURT AT CALCUTTA

NOTIFICATION

No. 133-G-9th January, 2007-In exercise of the powers conferred under Section 28 (1) of the Right to Information Act 2005 the Chief Justice of the Calcutta High Court (Competent Authority) is pleased to make the following rules to carry out the provisions of the 'Act' falling within the jurisdiction of this High Court:-

Rules

1. Short title and commencement:-

- * These rules may be called The Calcutta High Court (Right to Information) Rules, 2006
- * They shall come into force from the date of their publication in the Official Gazette.

2. Definitions:-

1) In these Rules unless, the context otherwise requires,-

- * 'Act' means The Right to Information Act, 2005 (No. 22 of 2005);
- * 'Appellate Authority' means designated as such by the Chief Justice of High Court at Calcutta;
- * 'authorized person' means Public Information Officers and Assistant Public Information Officer;

'Public Information Officer' shall mean—(i) the Deputy Registrar (Admn.) on the Appellate Side of the High Court and (ii) the Assistant Master and Referee on the Original side of the High Court (iii) Chief Judicial Magistrate in the District Courts (iv) the Additional Chief Judicial Magistrate in the respective sub-divisional courts.

Assistant Public Information Officer shall mean:-

- (i) In the Appellate Side of the High Court-
 - (a) Assistant Registrars of the respective departments
 - (b) Section Officer or Superintendent whoever is in-charge of the concerned department/section, where there is no post of Assistant Registrar.
- (ii) In the Original Side of the High Court -
 - (a) Assistant Registrars of the respective departments
 - (b) Section Officer or Superintendent whoever is in-charge of the concerned department/section, where there is no post of Assistant Registrar.

- (iii) In the Sadar Sub-divisional courts the senior most Civil Judge (Jr. Div.).
 - 'Form' means the Forms appended to these Rules for enforcement of the provisions of this
 - 'Section' means a section of this 'Act'
- (2) Word and expressions used but not defined in these Rules shall be the same meaning as assigned to them in respectively in the 'Act';

3. Request for obtaining information :-

A request for obtaining information may be made in writing or through electronic means in English, Hindi or Bengali accompanying a fee as prescribed below, by the person who desires to obtain the information to the Public Information Officer or the Assistant Public Information Officer, specifying the particulars of the information sought by him or her in the form prescribed below:-

In case the request cannot be made in writing the concerned Public Information Officer shall render reasonable assistance to that person to reproduce the same in writing.

All other provisions of section 6 of the Act shall apply in this respect.

4. Disposal of requests :-

For disposal of the requests under section 6 of the Act, the Public Information Officer or the Assistant Public Information Officer shall follow the provisions of section 7 of the 'Act'.

5 Protected/exempted information:-

The Public Information Officer or the Assistant Public Information Officer as the case may be have no obligation to give information to any citizen in the matter disclosure of which has been exempted under Section 8 of the Act.

6. Appeal:-

An appeal under section 19 of the "Act" may be preferred to the Appellate Authority, by the person who does not receive a decision within the time specified in section 7(3)(1)(a) of the Act or who is aggrieved by decision of the Public Information Officer or the Assistant Public Information Officer, as the case may be, in the time prescribed under section 19 (1) of the Act which may be extended as per provision or that section 19 (1) of the Act.

All other provisions of the Act shall apply for effective enforcement of the provisions relating to information as per Section 2(f) of the Act.

7. Penalties:-

- (1) whenever being bound to supply information fails to furnish the information asked for under Act within the time specified or fails to communicate the rejection order, shall be liable to a penalty up to fifty rupees per day for the delayed period beyond thirty days subject to maximum of five hundred rupees per application filed under rule 3 as may be determined by the Appellate Authority.
- (2) where the information supplied is found to be false in any material particular and which person is bound to supply it knows and has reason to believe it to be false or does not believe it to be true, the person supplying the information shall be liable to pay a penalty of a thousand rupees, to be imposed by the Appellate Authority, information provided that the Public Information Officer or the Assistant Public Information Officer, as the case may be shall be given reasonable opportunity of being heard before the penalty is imposed on him.

8. Suo motu publication of information by public authorities :-

- the public authority shall suo motu publish information as per sub-section (1) of section under the Act by publishing booklets and/or folders and/or pamphlets and update these publication every year as required by sub-section (1) of Section 4 of the Act.
- Such information shall also be made available to the public through information counter medium of internet and display on notice board at conspicuous places in the office of the authorized person are the Appellate Authority.

9. Fees:-

The authorized person shall charge the fee at the following rates:-.

Application Fee:-

Information relating to tenders Five hundred rupees per application (i) documents/bids quotation/business contract Information other than above

contract: Other Fees:

Fifty rupees per application

ANNEXURE 3

EXCLUSION FROM THE ACT
